Dear Sir/Madam,

1. By means of law No 4470 of 8<sup>th</sup> May 2017 published in the Official Government Gazette (No. 65/2017) the Hellenic Republic acceded to the Ballast Water Management Convention (the Convention). Consequently, on 26<sup>th</sup> June a document of accession to the Convention was officially deposited to the IMO Secretariat.

2. In this context, we would like to inform you that Greece, in its capacity as flag State, may issue, from 8<sup>th</sup> May 2017 and consequently earlier from the date of the Convention's international entry into force (8<sup>th</sup> September 2017), the International Ballast Water Management Certificates, as provided for in the same Convention, to ships flying the Greek flag, upon successful completion of a survey verifying that they comply with the provisions of the Convention, either itself or through duly authorized Recognized Organizations.

3. We would be grateful if the IMO Secretariat could circulate this notification to the IMO Member States for their information.

4. We avail ourselves of this opportunity to renew to the IMO Secretariat the assurances of our highest consideration.
